The following notification shall be published in the next issue of the Extra ordinary Official Gazette:-

NOTIFICATION

WHEREAS, the Government of Puducherry with a view to enforce the provisions of the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 (Central Act No. 27 of 1996) (herein after referred to as the 'Main Act') has notified rules namely the Puducherry Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2001 vide G.O.Ms.No.25/2001/Lab/AIL/G, dated 28th August 2001 of the Official Gazette No.14 dated 29.08.2001 and accordingly constituted the Puducherry Building and Other Construction Workers Welfare Board vide G.O.Ms No.44/Lab/AIL/G/2002, dated 23.12.2002 of the official Gazette No.2 dated 14.01.2003. The Building and Other Construction Workers Welfare Cess Act, 1996 (Central Act No. 28 of 1996) (herein after referred to as Cess Act) and the Building and Other Construction Workers Welfare Cess Rules, 1998 (hereinafter referred as the Cess Rules) have been enacted for the purpose of collection of cess so as to augment resources for the Board;

AND WHEREAS as per section 2(1) (d) of the Main Act, "building and other construction work" means construction, alteration, repairs, maintenance or demolition, of or, in relation to, buildings, streets, roads, railways, tramways, airfields, irrigation, drainage, embankment and navigation works, flood control works including storm water drainage works, generation, transmission and distribution of power, water works including channels for distribution of water, oil and gas installation, electric lines, wireless, radio, television, telephone, telegraph and overseas communication, dams, canals, reservoirs, watercourses, tunnels, bridges, viaducts, aquaducts,

pipelines, towers, cooling towers, transmission towers and such other work as may be specified in this behalf by the appropriate Government, by notification but does not include any building or other construction work to which the provisions of the Factories Act, 1948 (63 of 1948), or the Mines Act, 1952 (35 of 1952), apply;

AND WHEREAS, as per section 2(1) (j) of the Main Act "establishment" means any establishment belonging to, or under the control of, Government, anybody corporate or firm, an individual or association or other body of individuals which or who employs building workers in any building or other construction work; and includes an establishment belonging to a contractor, but does not include an individual who employs such workers in any building or construction work in relation to his own residence the total cost of such construction not being more than rupees ten lakhs;

AND WHEREAS, as per section 2 (1) (i) of the Main Act "employer" means in relation to an establishment, means the owner thereof, and includes-

(i) in relation to a building or other construction work carried on by or under the authority of any department of the Government, directly without any contractor, the authority specified in this behalf, or where no authority is specified, the head of the department;

(ii) in relation to a building or other construction work carried on by or on behalf of a local authority or other establishment, directly without any contractor, the chief executive officer of that authority or establishment;

(iii) in relation to a building or other construction work carried on by or through a contractor, or by the employment of building workers supplied by a contractor, the contractor;

AND WHEREAS, as per section 2 (1) (g) of the Main Act "contractor" means a person who undertakes to produce a given result for any establishment, other than a mere supply of goods or articles of manufacture, by the employment of building workers or who supplies building workers for any work of the establishment, and includes a sub-contractor;

AND WHEREAS, as per section 2 (1) (e) of the "Main Act "building worker" means a person who is employed to do any skilled, semi-skilled or unskilled, manual, supervisory, technical or clerical work for hire or reward, whether the terms of employment be expressed or implied, in connection with any building or other construction work but does not include any such person-

- (i) Who is employed mainly in a managerial or administrative capacity; or
- (ii) who, being employed in a supervisory capacity, draws wages exceeding one thousand six hundred rupees per mensem or exercises, either by the nature of the duties attached to the office or by reason of the powers vested in him, functions mainly of a managerial nature;

AND WHEREAS, section 7 of the Main Act provides for mandatory registration of any "establishment" and the Registering Officers and Appellate Officers have been notified vide G.O.Ms.No.33/2001/Lab/G dated 13.12.2001 (Annexure-1) and G.O.Ms.No.34/2001/Lab/G dated 13.12.2001 (Annexure-2) respectively;

AND WHEREAS, section 3 of the Cess Act provides for mandatory levy and collection of cess on the "building and other construction work" and the Government of India vide P 18/c notification No. S-61011/9/95/-RW [SO2899] dated 26.09.1996 has provided that the cess shall be levied @ 1% of the cost of "building and other construction work".

And WHEREAS, the Government of Puducherry has notified the Assessing Officers for assessment of cess under the Cess Act vide G.O.Ms No.23/LAB/AIL/G/2013, dated 26.06.2013 (Annexure-3) and the Appellate Authority for making any appeal against assessment order vide G.O.Ms No.22/LAB/AIL/G/2013 dated 26.06.2013 of the Official Gazette No. 28 dated 09.07.2013 (Annexure -4).

AND WHEREAS, the Government of Puducherry has notified the Cess Collectors for collection of cess under the Cess Act vide G.O.Ms No.8/2002/Lab/AIL/G, dated 05.03.2002 of the Official Gazette No. 45 dated 12.03.2002 (Annexure-5);

AND WHEREAS, section 3(2) of the Cess Act provides that the cess shall be collected from every employer in such a manner and at such time, including deduction at source in relation to a building or other construction work of a Government or of a Public Sector Undertaking or advance collection through a local authority where an approval of such building or other construction work by such local authority is required, as may be prescribed;

NOW THEREFORE, the Lieutenant-Governor, Puducherry is pleased to order

- (i) All Government Departments including Central Governments/Offices/ Units/Agencies such as Railways, Airport, Telecom, All India Radio, Doordarshan, CPWD, JIPMER, Cost Guard, Pondicherry University and other Central Institutes, Public Sector Undertakings and other Governmental Agencies/ Local Bodies (herein after referred as Public authorities) carrying out any building and other construction work by themselves shall be registered under section 7 of the Main Act with the concerned **Registering Officer**;
- (ii) All the Public authorities carrying out any building and other construction work through contractors or any sub-contractors hired by the main contractors shall ensure that the contractors are registered under section 7 of the Main Act with the concerned **Registering Officer**;
- (iii) All the Public authorities shall incorporate registration clause in the tender as well as in the contract agreement. They should verify the registration under section 7 of the Act before commencement of the work;
- (iv) All private employers/builders undertaking the work costing more than Rs.5 Crores are directed to get all workers engaged by them

registered with the Puducherry Building and Other Construction Workers Welfare Board and that no worker who has not registered with the Board shall be engaged in the construction work.

- (v) All the Public authorities carrying out any building and other construction work by themselves specified in clause (i) above shall remit the cess amount @ 1% of the total cost of the construction by way of crossed demand draft, in favor of the Puducherry Building and Other Construction Workers Welfare Board, Puducherry within 30 days of making such payment along with a forwarding letter addressed to the Puducherry Building and Other Construction Workers Welfare Board, Puducherry;
- (vi) All the Public authorities shall in case of building and other construction work specified in clause (ii) above shall deduct the cess amount @ 1% of the total cost of the construction as per the tender notification from the bills at the time of making payment to the contractors by way of crossed demand draft drawn in favor of the Puducherry Building and Other Construction Workers Welfare Board, Puducherry within 30 days of making such payment along with a forwarding letter addressed to the Puducherry Building and Other Construction Workers Welfare Board Puducherry;
- (vii) All Plan Approval Authorities shall after approval of the plan forward a copy of the plan approval to the Assessing Officer appointed for the purpose not later than 30 days. Where the prior approval of the construction work is required from the Statutory Bodies they shall determine the cess amount 32/LAB/AIL/G/2013, based on the G.O. Ms. No dated 16.09.2013 (Annexure-6) which is subject to periodical revision and remit the cess amount to the Board through demand draft drawn in favor of the Board along with forwarding letter containing the employer details and amount within 30 days in terms of rule 5(3) of the cess Rules, 1998. The authorities collecting cess may deduct from the cess collected, or claim from the Board, as the case may be, actual collection expenses not exceeding 1% of the total amount collected/remitted to the Board. A quarterly return on the details of cess collected shall be sent to the Cess Collector with a copy marked to the Secretary, Puducherry Building and Other Construction Workers Welfare Board, Puducherry;
- (viii) Where the building and other construction work undertaken by private employers/builders is likely to exceed one year, the employer/builder may pay the entire cess amount in advance or in the alternative, the authorities concerned shall at the time of plan approval obtain from the builder/employer, the stages of construction during the first year and subsequent years including the date on which the cess has to be paid in accordance with rule 4 (2) of the Cess Rules for each stage in a notarized affidavit and accordingly the cess may be collected and remitted to the Board;
- (ix) As provided under section 2(j) of the Act, in case of individual residential plans, the 1 % cess shall be collected only when the estimated cost is more than Rs.10 Lakhs;

- (x) In respect of Group Housing Societies, the Managing Committee of the Society is liable to pay the cess. Where the building is built by the builders, builder shall be liable. In the cases of the collaboration agreements where builder is constructing or has constructed the building in collaboration with the owner of the land / original building on sharing basis, the cess would be recovered from the builder or owner or both as per the collaboration agreement. It shall be ensured that no building plan is approved of by such local bodies without collecting 1% cess;
- (xi) In terms of section 4 of the Cess Act, 1996 and rule 7 of the Cess Rules,1998 every employer of the establishment shall furnish a return in Form-I (Annexure-7) to the concerned Assessing Officers as notified. Similarly, every employer of the establishment covered under this statutory provisions of the Main Act/Rules shall furnish a return in Form-XXXI (details of workers for registration) (Annexure-8) and Form-XXV (annual return to the Registering Officer) (Annexure-9) to the Registering Officers/Cess Collectors as required and under rule 243 and 270 of the Puducherry Building and Other Construction Worker Rules, 2001.

The following notification shall be published in the next issue of the Official Gazette.

NOTIFICATION

WHEREAS for the benefit of the Construction Workers in this Union territory 1 % of the cost of construction of the buildings under construction is being collected as Cess as per the provisions of Building and Other Construction Workers' Welfare Cess Act, 1996 (Central Act 28 of 1996) for the purposes of the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 (Central Act 27 of 1996);

AND WHEREAS due to non-availability of reliable data on the expenditure involved in the construction of buildings, the collection of cess is not commensurate with the actual cost of the buildings;

AND WHEREAS to derive at a reliable data on the expenditure involved in the construction of buildings, a meeting was held on 22.04.2013 Chaired by the Secretary to Government (Labour) and the Officials from the Public Works Department, Puducherry Planning Authority and Labour Department participated in the meeting and in this meeting it was recommended to revise the methods of assessment of cess under the said Act:

NOW THEREFORE, the Lieutenant-Governor, Puducherry has been pleased to order that the cess collected under the provisions of the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 shall be calculated on the basis of the following standard value, namely:-

The Chief Inspector or Inspectors appointed by a State Government under the Act shall direct the owners of establishments registered under this Act, to send the copies of Annual Returns submitted by the employers of registered establishments in respect of the State Government or to the Chief Inspector of Inspection by virtue of provisions of Section 60 of the Act.

The Chief Inspector or Inspectors appointed under this Act by a State Government shall direct the owners of such establishments as are registered under this Act by registering officers appointed by the concerned State Government to send copies of the Annual returns to the Chief Inspector by virtue of provisions of section 60 of the Act.
