NOTIFICATION

In exercise of the powers conferred by section 13 of the Puducherry Town and Country Planning Act, 1969 (Act No. 13 of 1970) and in supersession of the Notification issued in G.O. Ms. No.13/2010-Hg., dated 1st July 2010 of the Chief Secretariat (Housing), Government of Puducherry and published as a Supplement to the Official Gazette No. 27 of the 6th July 2010, save as respects things done or omitted to be done before such supersession, the Lieutenant-Governor, Puducherry, hereby makes the following rules regulating the method of recruitment to the Group 'A' Technical post of Member-Secretary in the Puducherry Planning Authority, namely:—

- 1. Short title and commencement.— (1) These rules may be called the Puducherry Planning Authority, Group 'A' Technical post of Member-Secretary Recruitment Rules, 2016.
 - (2) They shall come into force on and from the date of their publication in the Official Gazette.
- 2. Number of post, its classification and Pay Band and Grade Pay/Pay Scale.— The number of the said post, its classification and the Pay band and Grade Pay/Pay Scale attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed hereto.
- 3. Method of recruitment, age limit and other qualifications.— The method of recruitment to the said post, age-limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedule.
 - 4. Disqualifications.— No person,—
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Lieutenant-Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax.— Where the Lientenant-Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing relax any of the provisions of these rules with respect of any class or category of persons.
- 6. Savings.— Nothing in these rules shall affect the reservations, relaxation in upper age-limit and other concessions required to be provided for the Scheduled Castes and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard.
